An Enactment to amend the National Forestry (Adoption) Enactment 1987 [*En. No. 1/1988*].

[]

WHEREAS Parliament, pursuant to Clause (1)(b) of Article 76 of the Federal Constitution, for the purpose of promoting uniformity of the laws of the states of Malaysia, has made law known as the National Forestry Act 1984 [*Act 313*] with respect to the administration, management and conservation of forests and forestry development.

AND WHEREAS, according to Clause (3) of Article 76 of the Federal Constitution, the said Act, once adopted by the Legislature of a State shall than be deemed to be a state law and not a federal law capable of being amended or repealed by a law made by that Legislature:

NOW, THEREFORE, IT IS ENACTED by the Legislature of Perlis as follows:

Short title and commencement

1. (1) This Enactment may be cited as the National Forestry (Amendment) (No. 1) Enactment 2023.

(2) This Enactment shall come into operation on 1 April 2023.

Amendment of section 4

2. The National Forestry (Adoption) Enactment 1987 [*En. No. 1/1988*], which is referred to as the “principal Enactment” in this Enactment, is amended in Paragraph (*e*) Section 4 by deleting the word “and state park”.

Amendment of section 10

3. Subsection 10(1) principal Enactment is amended by deleting Paragraph (*l*).

WHEREAS Parliament, pursuant to Clause (1)(b) of Article 76 of the Federal Constitution, for the purpose of promoting uniformity of the laws of the states of Malaysia, has made law known as the National Forestry (Amendment) Act 2022 [A1667] with respect to the administration, management and conservation of forests and forestry development.

AND WHEREAS, according to Clause (3) of Article 76 of the Federal Constitution, the said Act shall not come into operation in a state unless it has been adopted by a law made by the Legislature of that State:

NOW, THEREFORE, IT IS ENACTED by the Legislature of Perlis as follows:

Short title and commencement

1. (1) This Enactment may be cited as the National Forestry (Amendment) (No. 2) (Adoption) Enactment 2023.

(2) This Enactment shall come into operation on 1 April 2023.

Adoption National Forestry (Amendment) Act 2022 [A1667]

2. Pursuant to the Clause (3) of Article 76 of the Federal Constitution, the National Forestry (Amendment) Act 2022 [A1667] are hereby adopted for the state of Perlis.
