DIPERBUAT UNDANG-UNDANG ini oleh Majlis Undangan Negeri Perlis seperti yang berikut:

Tajuk ringkas dan permulaan kuat kuasa

1. (1) Enakmen ini bolehlah dinamakan Enakmen Undang-Undang Tubuh Kerajaan Perlis (Pindaan) 2022.

(2) Enakmen ini hendaklah mula berkuat kuasa pada 1 November 2022.

Perkara baharu 50A

2. Undang-Undang Tubuh Kerajaan Perlis dipinda dengan memasukkan selepas Perkara 50 Perkara yang berikut:

“Pertukaran parti politik anggota, dsb.

50A. (1) Tertakluk kepada peruntukan perkara ini, seseorang ahli Dewan Negeri hendaklah berhenti menjadi ahli Dewan Negeri dan kerusinya hendaklah menjadi kosong sebaik sahaja suatu tarikh kekosongan luar jangka dipastikan oleh Speaker di bawah Fasal (3) jika—

(a) setelah dipilih ke Dewan Negeri sebagai anggota suatu parti politik —

(i) dia melepaskan keanggotaan parti politik itu; atau

(ii) dia tidak lagi menjadi anggota parti politik itu; atau

(b) setelah dipilih ke Dewan Negeri bukan sebagai anggota suatu parti politik, dia menyertai suatu parti politik sebagai anggota.

(2) Seseorang ahli Dewan Negeri tidak berhenti menjadi ahli Dewan Negeri menurut perkara ini hanya disebabkan oleh—

(a) pembubaran atau pembatalan pendaftaran parti politiknya;

(b) pelepasan keanggotaannya daripada parti politiknya apabila dipilih sebagai Speaker; atau

(c) pemecatannya daripada keanggotaan dalam parti politiknya.

(3) Apabila Speaker menerima notis bertulis daripada mana-mana ahli Dewan Negeri mengenai berlakunya kekosongan luar jangka dalam kalangan ahli Dewan Negeri di bawah

perkara ini, Speaker hendaklah memastikan bahawa berlakunya kekosongan luar jangka itu dan memberitahu Suruhanjaya Pilihan Raya sewajarnya dalam tempoh dua puluh satu hari dari tarikh dia menerima notis bertulis itu.

- (4) Bagi maksud mengadakan pilihan raya di bawah Fasal
(5) Perkara 55, kekosongan luar jangka itu hendaklah diisi dalam tempoh enam puluh hari dari tarikh Suruhanjaya Pilihan Raya menerima pemberitahuan itu daripada Speaker.

An Enactment to amend the Laws of the Constitution of Perlis.

ENACTED by the Legislature of the State of Perlis as follows:

Short title and commencement

1. (1) This Enactment may be cited as the Laws of the Constitution of Perlis (Amendment) Enactment 2022.

(2) This Enactment shall come into operation on 1 November 2022.

New Article 50A

2. The Laws of the Constitution of Perlis is amended by inserting after article 50 the following section:

“Change of a member’s political party, etc.

50A. (1) Subject to the provisions of this article, a member of the Legislative Assembly shall cease to be a member of that Legislative Assembly and his seat shall become vacant immediately on a date a casual vacancy is established by the Speaker under Clause (3) if—

(a) having been elected to the Legislative Assembly as a member of a political party—

(i) he resigns as a member of the political party;
or

(ii) he ceases to be a member of the political party;
or

(b) having been elected to the Legislative Assembly otherwise than as a member of a political party, he joins a political party as a member.

(2) A member of the Legislative Assembly shall not cease to be a member of that Legislative Assembly pursuant to this article only by reason of—

(a) the dissolution or cancellation of the registration of his political party;

(b) his resignation from the membership of his political party upon election as a Speaker; or

(c) the expulsion of his membership of his political party.

(3) Whenever the Speaker receives a written notice from any member of the Legislative Assembly on the occurrence of a casual vacancy among the members of the Legislative

Assembly under this article, the Speaker shall establish that there is such a casual vacancy and notify the Election Commission accordingly within twenty one days from the date he received the written notice.

(4) For the purposes of holding an election under Clause (5) of Article 55, such casual vacancy shall be filled within sixty days from the date the Election Commission receives the notification from the Speaker.
