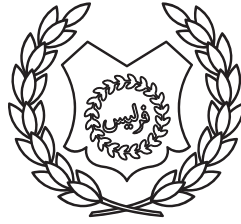

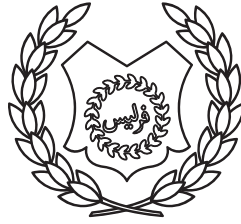

An Enactment to apply a sum from the Consolidated Fund for the services of the year 2015 and to appropriate that sum of the services for that year.

ENACTED by the Legislature of Perlis as follows:

Short title and commencement

1. This Enactment may be cited as the Supply Enactment 2015 and shall come into force on 1 January 2015.

Issue and appropriation for the services of the year 2015

2. The issue of a sum not exceeding One Hundred Sixty Four Million Twenty Three Thousand One Hundred and Sixty (RM164,023,160.00) from the Consolidated Fund for the service of the year 2015 is hereby authorized and that sum is appropriated for purposes specified in the Schedule:
